- Changing your name?

## **KNOW YOUR RIGHTS**

You have the right to be involved in your service planning meetings. You have the right to be given a copy or summary of each service plan and service plan review.

You have the right to attend your court hearings.  
You have the right to speak to the judge.

You have the right to send and receive unopened mail. You have the right to make and receive private phone calls.

You have the right to report abuse, neglect, or exploitation without fear of punishment or retaliation.

You have the right to visit and have contact with your family, including brothers and sisters, unless specifically denied by a court of law. If the court has denied visitation, you have the right to be told why and have both the denial and the reasons documented in your record.

If you are at least sixteen years old, you have the right to keep your own money. You have the right to open a bank account.

You have many, many more rights.

## **TAKE ACTION TO KEEP YOUR RIGHTS**

**If you know your legal rights and take action based on that knowledge, you have the power to change the system. You have the power to make the system better. It's up to you to speak out so that your rights are protected.**
